



Mirboo North Market Market Money Terms and Conditions

This document sets out the rules and terms and conditions of your entry to the **trade promotion lottery** for the Mirboo North Market, hereafter called **Market Money**.

1. You enter this lottery by purchasing an item or multiple items in one payment transaction from any of the stalls holders present at the market. The purchase value is immaterial; the purchase is what qualifies you to enter.
2. For each **purchase transaction**, you will receive **one entry ticket** to the Mirboo North Market Money lottery.
3. You must fill this ticket out with your name and phone number (or email) **in front of our volunteers** at the Market Information Tent. Pens are provided at this locality to assist you complete this task. Write legibly.
4. You must enter the filled-out tickets in our Market Money Draw Box. Do not ask our volunteers to do this for you.
5. **Tickets not able to be read at the draw will be discarded** and another winner chosen.
6. Your tickets are then held securely by us until the lottery is drawn.
7. Due to the specific requirements of the regulations governing this type of lottery, the draw will be conducted 28 days before the next Market day; hence **the draw is not conducted at the market**.
8. If you are drawn as the Market Money winner, **the Market will make reasonable efforts to contact you** to advise you of your win. **If we cannot reasonably get in contact with you within 10 days of the next Market, we will choose another winner.** There will be no appeals or correspondence entered into.
9. You will be required to attend **the following Market** to claim your Market Money tokens and use them to shop for goods from the Market.
10. **Your Money Market token value expires at the end of the Market you attend for redeeming your tokens.** For the avoidance of doubt, you must spend all of your \$150 Market Money tokens in the one Market and by close of the Market day at 1 pm.
11. **Your Market Money tokens are not redeemable for cash - in part or in whole.** This means if you buy something for less than the face value of the Money Market token (\$5), **you will not receive change.**
12. You of course, may **augment any Market Money tokens with whatever cash input is required** to avoid losing token value. e.g.: if a product costs \$6, you can offer 1 token (\$5) and top it up with one dollar cash - instead of buying it with two token (\$10) and receiving no change.
13. **If you lose your Money Market tokens before lodging them** in our entry barrel, we are not able to replace them.
14. If you are not able to attend the Market for your winnings, it is entirely your responsibility to notify the Market of this fact **in reasonable time and by email only to market@mirboonorth.com** - SMS messages will **not be accepted** as evidence of any issue regarding your inability to attend. In such exceptional cases, the Market Coordinator may make alternative arrangements for your redemption of tokens activity.
15. If you are a Market Money winner and your allocated Market for any redemption activity is cancelled for any reason, the Market Coordinator will organise to have the Market Money available to you at a subsequent Market Day. The Market will not be held liable for any costs or impacts to you of having this redemption activity moved.
